## February 2019 JREI Home Price Indices

According to the February 2019 JREI Home Price Indices, which were released by the Japan Real Estate Institute on April 23, 2019, Composite stood at 91.90 (down 0.25% compared with the previous month), Tokyo 100.28 (down 0.48%), Kanagawa 87.21 (down 0.09%), Chiba 72.75 (up 1.37%), and Saitama 75.29 (down 0.52%).

Exhibit 2: Year-on-Year Change Trends (last 10 years)

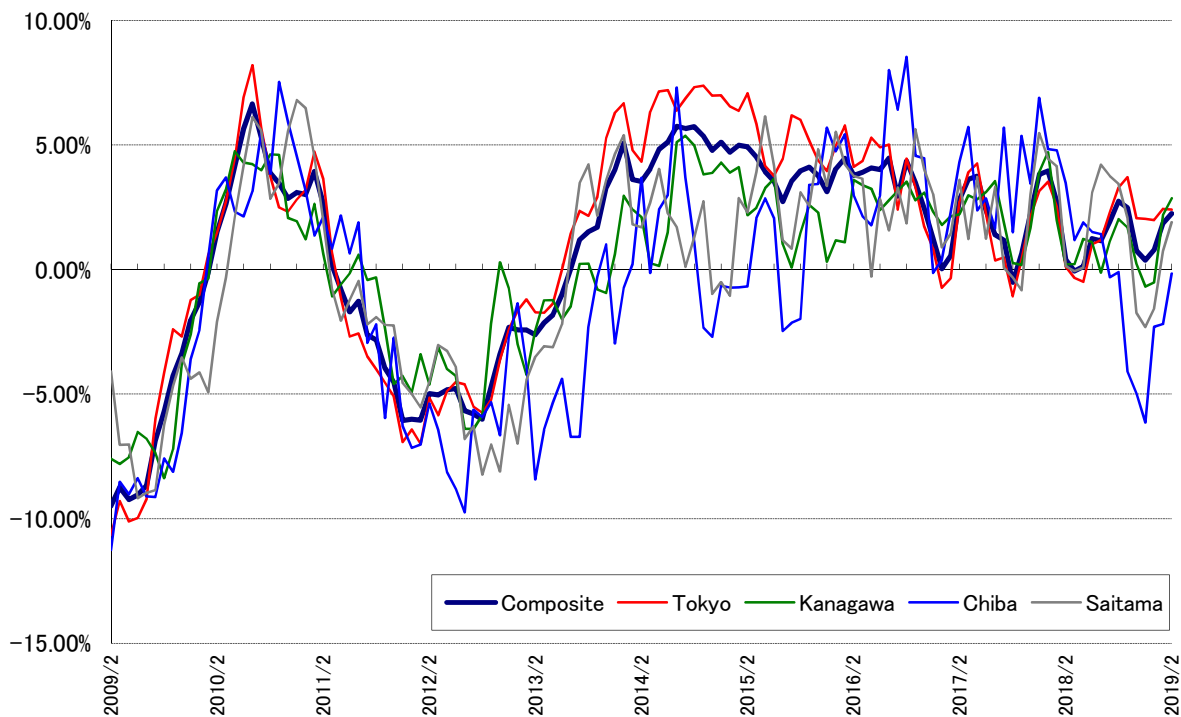


Exhibit 3: JREI Home Price Indices (last 10 years) January 2000 = 100

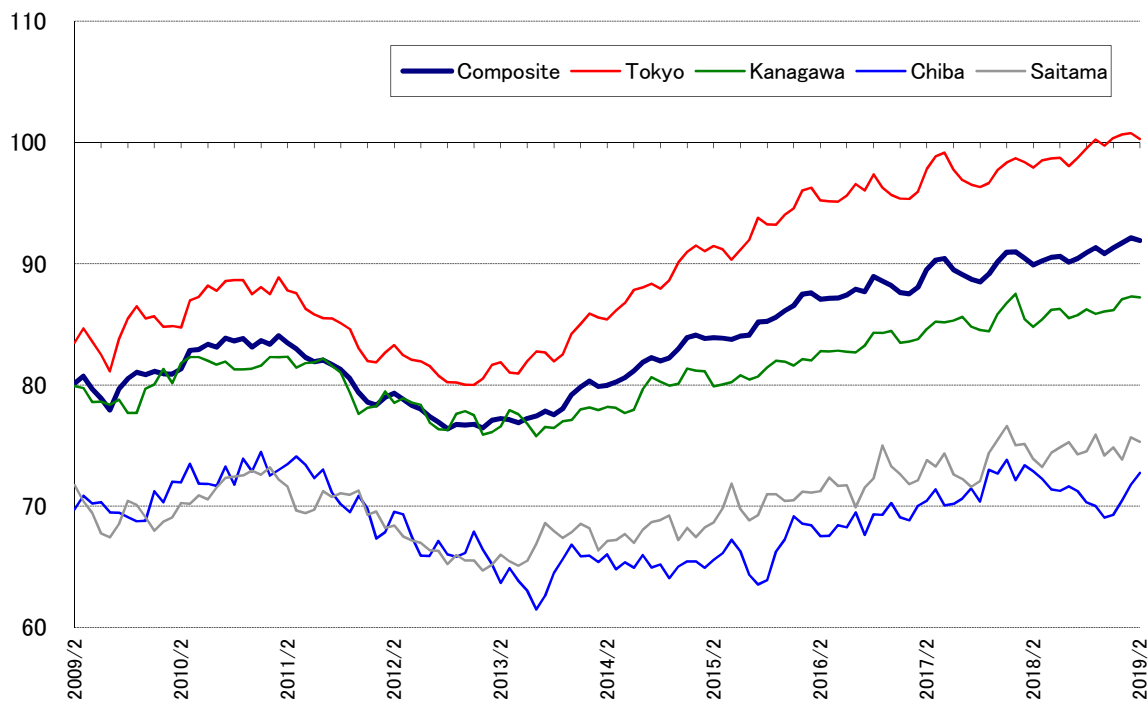


Exhibit 4: Year-on-Year Change Trends (since June 1994)

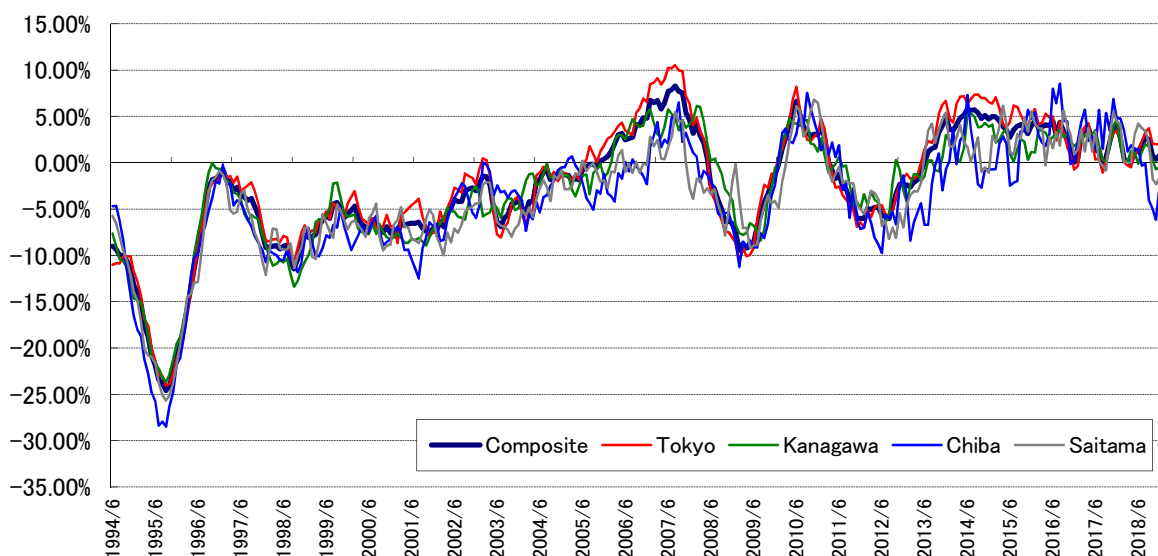
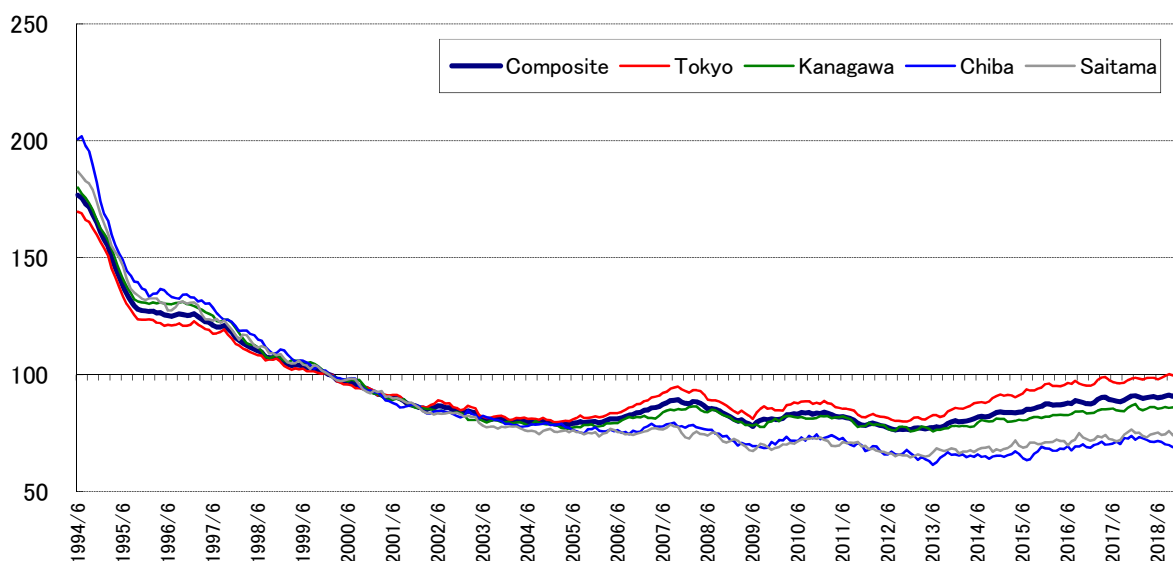


Exhibit 5: JREI Home Price Indices (since June 1994) January 2000 = 100
