## September 2020 JREI Home Price Indices

According to the September 2020 JREI Home Price Indices, which were released by the Japan Real Estate Institute on November 24, 2020, Composite stood at 94.20 (up 0.46% compared with the previous month), Tokyo 105.59 (up 0.76%), Kanagawa 84.76 (down 0.54%), Chiba 71.09 (up 0.69%), and Saitama 75.61 (up 0.40%).

Exhibit 2: Year-on-Year Change Trends (last 10 years)

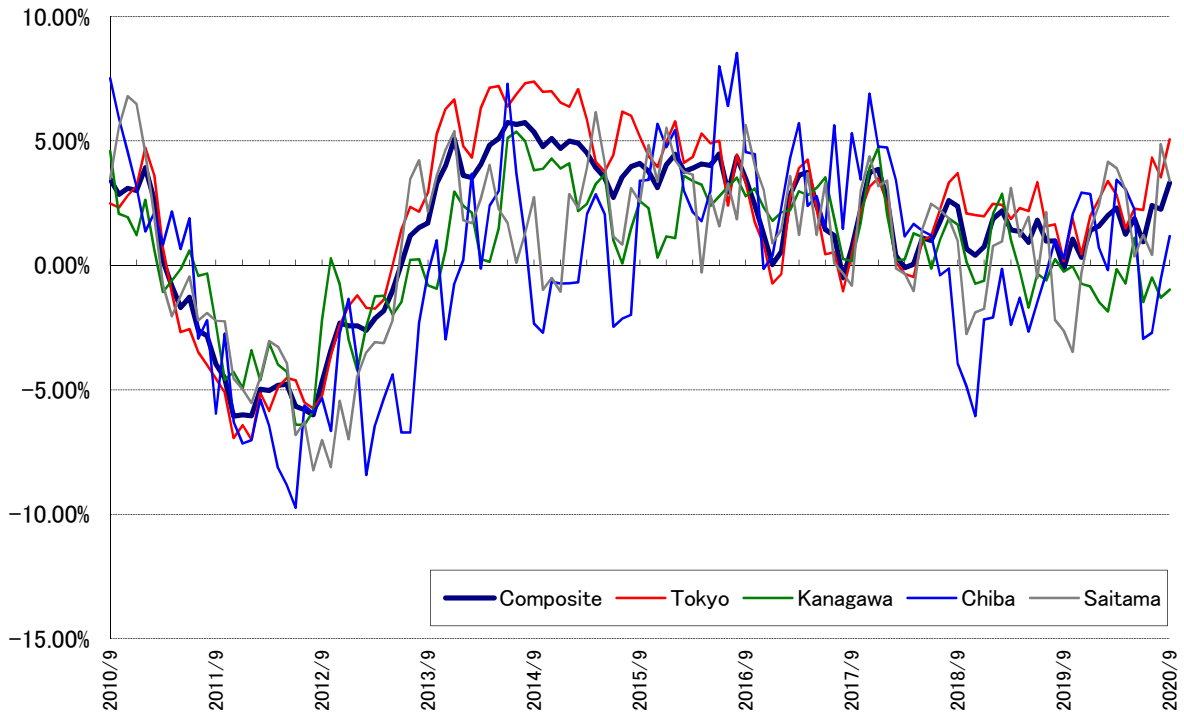


Exhibit 3: JREI Home Price Indices (last 10 years) January 2000 = 100

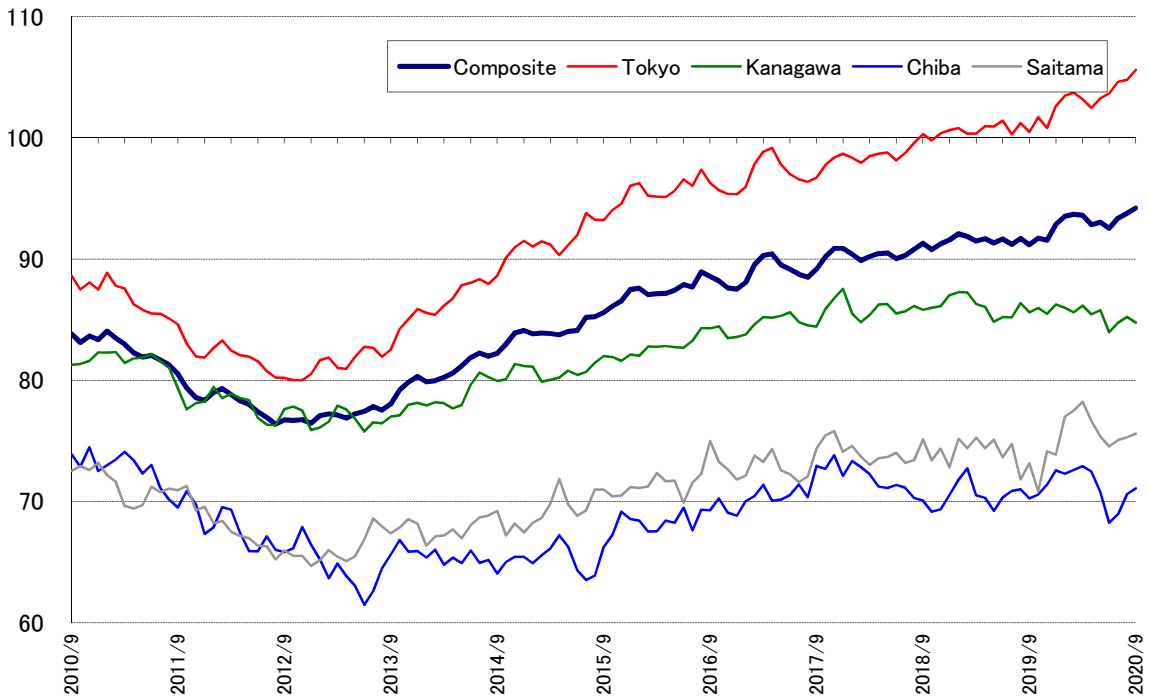


Exhibit 4: Year-on-Year Change Trends (since June 1994)

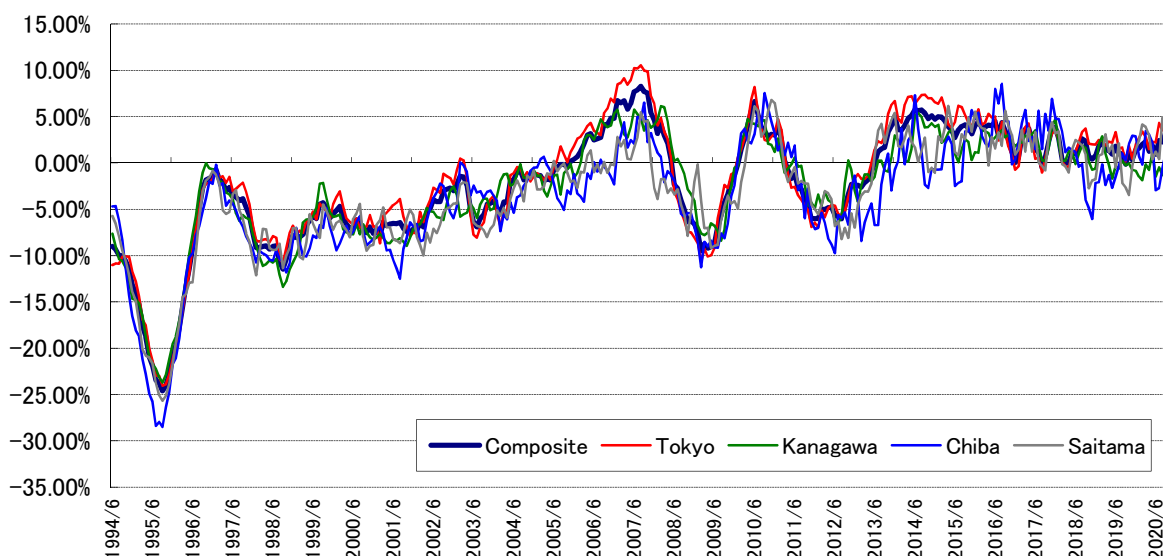
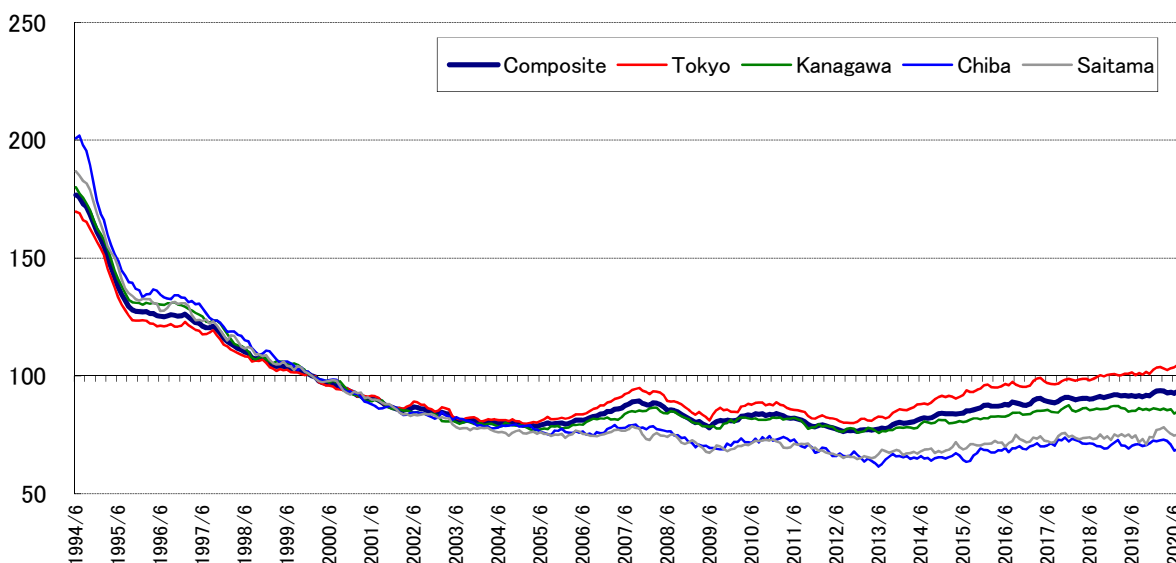


Exhibit 5: JREI Home Price Indices (since June 1994) January 2000 = 100
